#### SPRING CREEK HABITAT PROJECT UPDATE

In partnership with the PA Fish & Boat Commission and Clearwater Conservancy, habitat work was completed in August upstream of the former McCoy damn site between Bellefonte and Milesburg. The habitat work included construction of a floodplain bench, widening of the stream channel, installation of 4 rock cross vanes, and a number of additional in-stream habitat enhancement structures including 2 multi-log vane deflectors, 7 multi-log vane deflectors with root wads, 12 root wad deflectors, 4 modified mud sills, and 30 boulder placements along 2,000feet of stream. Riparian zone plantings are scheduled for September/October. Planning is underway for two (2) additional reaches that will be completed during the 2010 seasons.
